### **ABOUT SHAHEED HAMID ALI BHOJANI**


#### President (KPSIAJ) August 1988 – February 1995

# **MESSAGE FROM THE PRESIDENT**



### **ABUL HASSAN GOKAL**

#### Dear Members, Assalam o Alaikum;

All praise be to Allah for His guidance through the greatest of all books, the Holy Quran; and the best of all creations, Prophet Muhammad (saww), and for providing us with the familiarization and love for the Ahle Bait - who are our beacon of light.

#### KPSIAJ – An overview:

The economy continues to present challenges, especially to the middle- and lower-income segments. KPSIAJ has risen to meet these challenges by increasing its welfare activities and alleviating the plight of its members. However, much more can be accomplished with the support of relatively affluent members.

Operational efficiencies across KPSIAJ and its institutions have been encouraged with the help of diligent professionals. Community and donor engagement has improved significantly. The Fatimiyah Hospital mega-expansion project is underway; construction on one plot has commenced, and possession of the adjacent plot has been secured. Additionally, the plot adjacent to the FEN Building has been finalized, and payments are being made as per the schedule.

#### The AGM:

Annual General Body Meetings are strategic events attended by the General Body to stay updated on the organization's progress and performance, as well as to provide feedback for improvement in a corporate culture. Unfortunately, this once-a-year opportunity to share ideas is sometimes reduced to an Annual Grievance Meeting by some members. They reserve their complaints for the AGM rather than communicating them to the relevant departments at the Jamaat for quicker resolution. Moreover, some complaints pertain to individual issues rather than being General Body concerns. Such conduct and misuse of General Body time are unethical and must be collectively discouraged.

#### Message to the Community:

As we commemorate the days relevant to Janab-e-Syeda (s.a.), let us reflect on our Community's founding principles: the love and teachings of Ahle Bayt (a.s.).

Adherence to the Quran and the Ahlul Bayt has been prescribed by the Holy Prophet (PBUH) for the Ummah. While many of these teachings are preached from the pulpit, they often remain unimplemented in our lives. We must cultivate a strong affinity within ourselves and our society for understanding and following the true message of Islam as reflected in these teachings.

The Holy Quran is often treated as a ceremonial book—revered with respect, but rarely used as a source of guidance. Similarly, the traditions and practices of the Ahle Bayt (a.s.) are appreciated in gatherings but seldom integrated into our daily lives. This lack of adherence to these two pillars of guidance has led to a moral decline in society, characterized by a lack of tolerance, a culture of slander (tohmat), harassment, self-centeredness, and indifference to what is right and wrong.

To improve society, we must begin with small steps to first improve ourselves. Imam Hussain's (a.s.) final address at Karbala, where he stated, "My words will have no effect on you because your bellies are filled with impurities (haram)," emphasizes the importance of our diet. Even a pure (halal) diet has positive or negative effects on the body, mind, and soul, shaping one's character and behavior.

Our negligence toward our diet is evident in the increasing consumption of commercially prepared food, fostering a materialistic society. Foods that promote health for the body, intellect, and soul are mentioned in the Quran, yet they often fail to feature on our preferred list. Honey, olives, and dates are a few examples. Paying closer attention to our diet can improve our well-being—both as individuals and as a community.

As a community, we have a long journey ahead. Collective goals can be achieved through synergy, understanding, and harmony but are made more difficult by undue criticism and the demotivation of those striving to do their best.

### MINUTES OF THE ANNUAL GENERAL MEETING HELD ON SUNDAY THE 17TH DECEMBER 2023 AT SHAHEED HAMID ALI BHOJANI HALL, 174, BRITTO ROAD, KARACHI.

The Annual General Meeting of the Khoja (Pirhai) Shia Isna Asheri Jamaat was held on Sunday, December 17th, 2023, at 10:30 a.m. at Bhojani Hall, 174 Britto Road, Karachi.

Quorum was completed, and the meeting commenced at 10:30 a.m. 130 male and 6 female members, 136 members in all, were present at the meeting. List has been placed on record.

Mr. Abul Hassan Gokal, President of KPSIAJ, requested the Hon. Secretary, Hujjatul Islam Agha Asghar Hussain Shaheedi, to commence the proceedings of the AGM.

#### RECITATION OF VERSES FROM THE HOLY QURAN:

The Honorary Secretary Agha Asghar Hussain Shaheedi invited Master Safeer to recite verses from the Holy Quran. Following this, Master Muhammad Abbas was requested to recite salaam on Bibi Fatima Zehra S.A.

The Honorary Secretary then shared a few reflections and Hadith on the hardships and martyrdom (shahadat) of Bibi Syeda (S.A.) before formally welcoming the members to the Annual General Meeting.

He then requested all members to join in reciting Surah Al-Fatiha for the souls of Quaid-e-Azam Muhammad Ali Jinnah, Marhoom Allama Haji Naji, Marhoom Ghulam Hussain Chagla, Marhoom Rahim Ali Chagla, Karachi's first martyr Marhoom Laalan, Marhoom Ghulam Ali Chagla, Shaheed Hamid Ali Bhojani, Shaheed Dr. Sibtain Dossa, Moulana Yousuf Ali Nafsi, Dost Muhammad Bhojani, Marhoom Mohsin Hemani, Marhoom Nisar Hussain Virani, Marhoom Baqar Gokal, Marhoom Imran Gheewala, Marhoom Iqbal Lakhani, and all other marhumeen who served the community. He also included in the prayer the revered Meraj-e-Uzzam, Ulama-e-Karam, the martyrs (shohada) of Millat-e-Jaffariya, and the departed souls of all marhumeen momineen and mominaat. The agenda was then presented by the Honorary Secretary, Agha Asghar Hussain Shaheedi.

#### TO READ AND CONFIRM THE MINUTES OF THE LAST ANNUAL GENERAL MEETING HELD ON 18TH DECEMBER 2022:

The Hon. Secretary enquired the House whether the minutes should be taken as read (as it has been circulated to members through email and WhatsApp) and presented for approval.

Mr. Altaf Kikariyawala proposed adopting the minutes of the last AGM and the 2023 annual accounts, as both have been published in the annual report. Agha Shaheedi opened the quorum and invited members to raise any technical issues during the final session of Any Other Matters. Mr. Muhammad Ali Merchant advised members to review responses in the published minutes from

questions raised in the last AGM. Copies of last year's minutes are available for members in the hall to verify any previously missing points. The Honorable Secretary confirmed that the minutes, adopted conditionally last year, now include the required additions and are available for review upon request.

The Honorable Secretary invited questions regarding the adoption of the 2022 AGM minutes. Mr. Shahid Badami confirmed that all pending items have been incorporated.

Mr. Shahid Badami highlighted few corrections in the printed minutes: the total education subsidy on page 15 is 3 crores 95 lacs, with 1 crore 18 lacs (30%) for members, not 3 crores 39 lacs as printed. On page 10, Mr. Shahid Badami suggested developing a methodology to ensure the provision of maximum benefits to members. Mr. Ali Raza Vazir noted that, as previously mentioned, Fatimiyah School was not among the top 5 institutions listed on page 14 of the Annual Report. However, he did not say that and he clarified that it is, in fact, not even among the top 10.

The motion to adopt the 2022 AGM minutes was proposed by Mr. Shahid Salim, seconded by Mr. Shahid Badami, Mr. Altaf Kikeriyawala, Mr. Muhammad Ali Merchant, and Mr. Fida Khawaja.

#### TO CONSIDER AND ADOPT THE REPORT OF THE MANAGING COMMITTEE FOR THE YEAR ENDED 30-06-2023

The Managing Committee Report was accepted as read, proposed by Mr. Shahid Badami and seconded by Mr. Shahid Salim. Mr. Muhammad Ali Merchant informed the assembly about suggestions made by members in the 2022 AGM, which the Honorable Secretary advised should be addressed under "Any Other Matters."

#### TO CONSIDER AND ADOPT THE ANNUAL ACCOUNTS FOR THE YEAR ENDED 30TH JUNE 2023 TOGETHER WITH THE REPORT OF THE HONORARY TREASURER AND EXTERNAL AUDITOR:

The Annual Accounts for the year ending 30 June 2023, along with the Treasurer's and Auditors'

reports, were taken as read. The motion was proposed by Mr. Shahid Badami and seconded by Mr. Muhammad Ali Merchant.

The Honorable Secretary invited Mr. Asker Ali Basrawala to explain his report. Mr. Basrawala stated that Jamaat's activities are funded entirely through donations and revenue-generating measures to ensure accountability. He introduced the "Admin Expenses" module, which proportionally allocates the costs of finance, administration, media, IT, procurement, and HR across various operational areas.

Mr. Basrawala highlighted a 16% salary increase, with 14% for increments and 2% for new hires, reflecting growth in operational areas. He noted that the increasing demands of Fatimiyah Hospital require stronger support functions, and efforts are being made to enhance intellectual, financial, and resource capacities.

Mr. Muhammad Ali Merchant congratulated the team on a 3-million increase in the 2023 accounts. He raised several queries, including whether the food relief fund in the Treasurer's report reflects net expenses and whether the Fatimiyah International University fund is sourced from specific donors or general funds. He also inquired about the Provident Fund assets and whether a fund has been established for the open plot next to Fatimiyah Hospital.

Mr. Merchant expressed concern about funds held in bank not being invested to generate income. On page 9, point 11, he sought clarification on the 40.9 million listed as "Services Receivable" and suggested that investment profits should be recognized as earned rather than capitalized. He further questioned the financial management strategy, noting that inflation increases do not align with the reported shortfall. He asked whether the bank balances as of 30 June 2023 had been invested to earn profit. He also pointed out significant expense increases, including:

- Printing and stationery (3 to 7 million, including office supplies).
- Medical expenses (0.3 to 1.1 million).

Seminar costs, which rose sharply despite limited seminars.

Matrimonial services (678,000 compared to 53,980).

Mr. Merchant questioned whether flood relief expenses are included in the general welfare fund or managed separately. Additionally, he noted rises in administrative expenses, with "others" increasing from 968,000 to 1.195 million, and raised concerns about expense allocation practices. On point 20, Mr. Merchant requested details about a fund with net assets of 158 million and a cost of 145 million, suggesting there might be an unreported investment. He stressed the importance of maintaining a Trust Deed and associated accounts for such investments. Regarding discounts for members on hospital services, he inquired if expenditures decrease in proportion to the discounts provided.

Mr. Shahid Saleem observed that some categories show a surplus despite an overall deficit, likely due to Sindh Government grants. He opposed accepting these grants, citing the government's instability.

Mr. Shahid Saleem noted that multinational companies typically limit administrative expenses to 2–4% of total costs, whereas Jamaat's appear disproportionately high. He emphasized that expenses should be allocated based on the activities of each entity, such as the hospital, school, or administrative office, and reflected in their respective Profit and Loss (P&L) statements. For example, office supplies and security guard expenses for the hospital should be charged directly to the hospital, not grouped under general administrative costs. This approach would provide a clearer picture of each segment's financial situation.

The Annual Accounts for the year ending 30 June 2023, along with the Treasurer's and Auditors' reports, were presented and proposed for approval by Mr. Shahid Badami and seconded by Mr. Muhammad Ali Merchant.

Mr. Badami highlighted a 48% drop in education donations (from 43.75 million to 22.7 million) and a 62% increase in medical expenses due to office supplies, which rose from 8.7 million to 14.2 million. He noted that 10 million received as a government grant for patient welfare resulted in an overspend of 5 million after utilization.

Responding, Mr. Asker Ali Basrawala explained that deficits arise when income is lower than expenses, with donations allocated across sectors as needed. The 30 million education grant was partly redirected to capital expenditures. He clarified that Fatimiyah Hospital's 62% deficit increase was due to its base costs and added that healthcare revenue growth could be achieved through new projects and tariff adjustments.

Mr. Basrawala addressed administrative practices, stating that expenses are proportionately allocated across entities using a centralized system to avoid duplications. Inflation (30%) has affected bulk purchases by 20–25%, yet the deficit ratio has been maintained at 13–15%.

Regarding investments, the Provident Fund is included in the overall portfolio, with funds placed in government securities and savings accounts, yielding comparable returns of 20–22%. Flood relief and Fatimiyah International University funds are netted at year-end, reflecting liabilities. A 9-million profit receivable for June will be credited in July. Legal fees relate to a Fatimiyah Hospital case, with details available upon request. The accounts and reports were proposed by Mr. Shahid Salim, Mr. Shahid Badami, Mr. Iqbal Jiwani, and Mr. Raza (CWO) and seconded by Mr. Altaf Kikariyawala. The motion was carried.

#### TO APPOINT EXTERNAL AUDITORS FOR THE YEAR ENDED 30TH JUNE, 2024 AND TO FIX THEIR REMUNERATION, IF ANY:

The Honorable Secretary acknowledged the diligent work of Mr. Afzal Dossani from M/s. Dossani Associates as the auditor for Jamaat, praising his efforts in preparing and auditing the report, which offered valuable guidance to the team.

Mr. Altaf Kikariyawala proposed the reappointment of M/s. Dossani Associates as auditors for the 2023-2024 financial year. The proposal was seconded by Mr. Muhammad Ali Merchant, Mr. Shahid Salim, Mr. Shahid Badami, and Mr. Sarwar Ali. Following this, M/s. Dossani Associates was officially appointed as Jamaat's auditor for the upcoming financial year.

#### TO APPOINT ELECTION CHAIRMAN FOR THE FORTHCOMING ELECTIONS OF THE MANAGING COMMITTEE OF THE KHOJA (PIRHAI) SHIA ISNA ASHERI JAMAAT WITH TRI-ANNUAL MEETING, AS REQUIRED UNDER THE CONSTITUTION OF JAMAAT AND ITS BYE-LAWS:

The Honorable Secretary informed members that Mr. Haider Ali Sharif, the previous Election Chairman, has declined to continue his role in the upcoming elections. The Jamaat expressed heartfelt gratitude for his dedicated service over multiple terms, praying for Allah to reward him abundantly and bless him with good health for his contributions.

The General Body discussed potential candidates and shortlisted a few, with two individuals providing written consent to assume the role. The Secretary proposed Moulana Ghulam Raza Roohani Saheb as the first candidate. Following a majority vote by raised hands, Moulana Roohani Saheb was confirmed as the Election Chairman for the 2024 elections.

#### TO CONSIDER ANY OTHER MATTER WITH THE PERMISSION OF THE CHAIR:

Mr. Sarwar Ali raised concerns regarding changes in the hospital pharmacy's formulary practices, noting that it may no longer be readily accessible to consultants or fully implemented. He questioned why medications unavailable in the hospital pharmacy are still being prescribed, with approximately 20–30% of medications being purchased externally. Additionally, he highlighted a significant issue with medical stores opposite Fatimiyah Hospital stocking medications sourced from the hospital.

To address this, Mr. Ali suggested that consultants strictly adhere to the formulary to avoid prescribing non-available medicines. He also recalled the expansion of the hospital's laboratory between 2006 and 2010 and recommended further upgrades to make the lab self-sufficient.

Regarding MRI services, he advised against purchasing equipment outright, proposing that the hospital explore partnerships with companies like Abbott or Roche, which provide equipment at no cost in exchange for purchasing testing kits based on demand. This approach could reduce outsourcing and increase hospital revenue.

Mr. Sarwar Ali emphasized the need for a meeting with the hospital's 80+ consultants to encourage using in-house lab facilities, reducing outsourcing that could harm the hospital's reputation. He also requested that Mr. Yawar Abbas Kumali consider setting a reasonable time slot of 1–2 hours, on a first-come, first-served basis, to discuss fee issues with parents unable to pay. He criticized the current system of requiring parents to collect tokens at 6 a.m. as impractical and inconvenient.

Mr. Yousuf Ali Panjwani voiced concerns regarding the allocation of seats for senior citizens on Jamaat buses traveling to graveyards, noting that younger individuals often occupy these seats. He suggested that volunteers manage this issue to prioritize senior citizens. While he acknowledged the satisfactory operation of the bus service from Kharadar, Soldier Bazar, and other pickup points, he raised a question about the unavailability of certain medications in the Fatimiyah Hospital pharmacy, despite their availability in local stores in Soldier Bazar.

Mr. Shahid Badami expressed appreciation for the Jamaat's efforts, particularly for waiving sports complex fees for senior citizens, describing this as commendable. He emphasized the importance of the YES series for youth engagement and thanked donors for their continued support, specifically recognizing Mr. Riaz Hussain Premjee for

introducing the Premjee Awards in Fatimiyah Hospital. However, he reiterated a concern from the 2021 AGM, questioning why the names and contributions of Jamaat volunteers were not included in the 2023 annual report. He also referred to the dashboards on page 91 of the report, which he had requested since 2021, asking for member classification by categories such as inpatient and outpatient status to illustrate the percentage of members benefiting from Jamaat services. Additionally, he inquired about the specific number of members who received aid from the 50.5 million rupees allocated for educational welfare and the 25.9 million rupees allocated for hospital welfare.

Mr. Rizwan Merchant thanked the Honorable Secretary and Joint Secretary for the opportunity to contribute under Jamaat's banner. He shared welfare statistics, detailing the assistance provided to both members and non-members in areas such as education, ration support, and rent. Over the past six months, this aid amounted to approximately 6.5–6.8 million rupees, with an additional 1–1.5 million rupees directed to hospital-related support. Furthermore, Makatib-e-Pakistan contributed 7-8 million rupees during the flood relief period, which was used for housing and ration distribution. Agha Shaheedi personally visited interior Sindh to oversee these efforts.

Mr. Rizwan Merchant also raised concerns regarding the appointment of Hujjatul Islam wal Muslimeen Agha Roohani Saheb as Chairman of the Election Commission, questioning whether a religious figure was the best fit for this role. He contrasted this with the previous Chairman, Mr. Haider Ali Sharif, who had a close association with the scout team and demonstrated commendable rapport and administrative capability.

Mr. Rizwan Merchant raised concerns about the current standard of Fatimiyah Boys School (FBS), noting that the majority of the 15-member elected Jamaat team do not have their children enrolled there. He highlighted issues with discipline and stressed that while the school's tuition fee of Rs. 6,000 is lower than the Rs. 14,000 charged by other reputable schools, efforts must be made to improve its quality and reputation to encourage community members to prioritize FBS. He also sought feedback on the outcomes of Jamaat business seminars, questioning how many attendees had successfully launched businesses. Using an analogy, he urged the Jamaat to not only "teach members how to eat fish" but also "how to catch fish."

Mr. Merchant further inquired about mechanisms allowing white-collar members to discreetly seek welfare assistance without disclosing their identity, particularly given the rising cost of OPD services (Rs. 1,000). He also requested details of rent and housing schemes for Khoja members and proposed utilizing the squash area on the top floor of the FSC building for indoor cricket. Additionally, he reiterated the need for an updated list of volunteers and teams appointed by the Jamaat.

Mr. Rasheed S. Abdullah emphasized the importance of Gujarati, noting its relevance to many Jamaat members. He questioned why no part of the AGM had been conducted in Gujarati and why the annual general report was not printed in this language, urging immediate action to address these concerns.

Mr. Abid Hussain Virani raised practical concerns about the welfare token system, which requires members, including women from areas like Landhi and Malir, to arrive as early as 6 a.m. He deemed the current welfare allowance of Rs. 7,000 for families inadequate and suggested it be increased to meet current living expenses.

He also questioned extracurricular activities at Fatimiyah School, such as Karate Day and swimming, arguing that the requirements for special uniforms might burden families and overwhelm students. Regarding senior citizens, he proposed a medical or charity card system to help members aged 60 (males) and 55 (females) manage rising healthcare costs. Mr. Virani asked about the ration distribution system, noting that a store in Kharadar that lacked adequate inventory was chosen for the task. He urged transparency in awarding such contracts. Regarding insurance, he queried why the Jamaat transitioned from NJI to Alpha Insurance and whether there were any concerns with State Life Insurance. He also encouraged the Jamaat to continue utilizing government grants to avoid funds being classified as unclaimed government expenses, particularly in light of the worsening economic situation.

Miss Hira Batool from the Jamaat Youth Forum expressed gratitude to the Jamaat for providing opportunities for young women to engage in various activities, emphasizing the positive impact these initiatives have had on youth engagement and empowerment.

Mr. Muhammad Ali Merchant began by expressing gratitude for the contributions of Mr. Haider Ali Sharif, as well as the efforts of donors, volunteers, and facilitators supporting the Jamaat across various sectors. However, he disagreed with the views of Mr. Salim and Mr. Abid Hussain Virani regarding reliance on government grants. He noted that, unlike countries where governments provide education and healthcare for senior citizens, such support is lacking locally. Highlighting how associations like Aga Khan, Liaguat National, and the Memon community benefit from government grants, he stressed the importance of securing these funds for the community, which contributes taxes and deserves its share of support.

He commended Mr. Hassan Akbar and the Jamaat team for their successful efforts in obtaining grants from the Sindh government, emphasizing the need to pursue more grants for the community's benefit.

Mr. Merchant addressed the topic of endowments and investments, suggesting that more opportunities exist to reduce expenditures. He also reiterated his previous proposal to include details about the attendance of elected members at board meetings. Although this measure has not been implemented, he argued that recording attendance in the minutes would reflect members' commitment and enhance transparency. While acknowledging the efficiency of all members, he noted that addressing perceptions about certain individuals could strengthen trust and accountability.

Mr. Muhammad Ali Merchant addressed ongoing concerns regarding insurance, noting that approximately 3,000 members benefit from it but challenges remain. He clarified that insurance is now provided by Alpha Insurance instead of New Jubilee. Sharing a personal experience, he recounted how Aga Khan Hospital informed him that his family insurance card, which covered 10 lacs for two individuals, had expired, forcing him to pay 5 lacs out-of-pocket for his wife's treatment. He highlighted that this issue was mentioned in last year's minutes but has yet to be resolved.

Acknowledging the rising health concerns in Karachi, Mr. Merchant stressed the importance of efficient processing of insurance applications. He proposed individual insurance policies for cards to ensure coverage during emergencies. He emphasized the competitiveness of the insurance market and the need to negotiate better group insurance packages, particularly for senior citizens aged 60 and above.

Expressing gratitude for the recent discounts announced for community members at Fatimiyah Hospital, Mr. Merchant urged the Jamaat to establish clear criteria for senior citizen benefits. He also commended Mr. Afzal Dossani for his services and suggested launching fundraising initiatives, such as a community contribution of Rs. 100 per member combined with a ballot for Ziarat trips, to bolster the Patient Welfare Fund.

He offered to assist Mr. Yawar Kumaili in securing better insurance options, underscoring that even middle-class members require affordable insurance solutions. He praised the efforts of Miss Sara and Mr. Muhammad Ali for their consistent dedication and proposed a scheme to raise additional funds for patient welfare.

Hon. Secretary welcomed Mr. Muhammad Raza Devjani's remarks in Gujarati. He expressed gratitude to the Jamaat's elected team and commended the contributions of Mr. Haider Ali Sharif to the community. He also lauded the appointment of Agha Ghulam Raza Roohani as the new Election Chairman, expressing confidence in his team's ability to perform effectively.

Mr. Devjani proposed the introduction of a family insurance card that would provide collective coverage for all family members, eliminating the need for separate limits for individuals. He recommended negotiating with State Life Insurance Corporation to facilitate such an arrangement.

In addition, he suggested the establishment of a community-wide discounted ration program, modeled after the Memon Federation, which offers rations at a 20 to 30 percent discount. This initiative, he noted, would not only benefit members financially but also create employment opportunities within the community.

Mr. Ali Raza Vazir proposed that the minutes of the Annual General Meeting (AGM) be sent via email and WhatsApp within a month to enable immediate review, instead of waiting until the end of the year, which often leads to necessary changes later. He expressed concerns about the Jamaat's focus on establishing Fatimiyah University, questioning whether there are enough Khoja children to justify such an institution. If not, he suggested the university should consider a broader community focus. Mr. Vazir pointed out that the budget for higher education scholarships has dropped from 15 million to 8.7 million, while expenses for Fatimiyah University are rising sharply, exceeding 20 million this year.

He emphasized that modern education should prioritize skill development and specialized institutions over a comprehensive university. He also highlighted that successful education systems, like those in China, Japan, and Iran, operate in their native languages, suggesting that a similar approach should be considered for the Khoja community. Mr. Vazir also shared concerns from a Parent-Teacher Meeting, where a social studies teacher emphasized the importance of teaching in the native language but felt unable to communicate this effectively to the administration. He also pointed out а misalignment in the curriculum, as a computer science student faced a theoretical exam format that didn't align with practical needs.

Mr. Muhammad Zeeshan Namdar raised several issues at Fatimiyah Hospital, including parking problems that hinder timely emergency treatment and the inability to return medications purchased on prescription if the prescription changes. He also criticized the hospital's extra fees for card payments, whereas other hospitals offer discounts for such transactions. Mr. Namdar appreciated the YES programs but highlighted that students are often seen wandering around in school uniforms during early hours, which could be better managed. Additionally, he noted issues with ATMs at the hospital running out of cash or facing network errors and recommended collaborating with other banks to address this. He also suggested investing in Islamic banking and Takaful for insurance plans and inquired about the timeline for completing Fatimiyah University.

Mr. Yaseen Merchant praised the efforts of the current Jamaat team and echoed Mr. Rafiq Abdullah's concern that the Khoja community is not taking steps to preserve its native Gujarati language. He noted that other communities have successfully maintained their languages, which helps preserve their culture, and warned that neglecting Gujarati could result in the community's cultural erasure. Mr. Merchant proposed incorporating a half-hour Gujarati language instruction period into the school curriculum, offering his services as a teacher, and suggested a meeting with an elected Jamaat member to discuss this initiative further. He emphasized the need to decide whether to continue embracing the language or let it fade away.

Mr. Yaseen Merchant continued his advocacy for the preservation of the Gujarati language, noting that he had come across a single article by Mr. Shahzad Mehdavi discussing the language's decline. He pointed out the lack of visibility for Gujarati in the community, mentioning that he had only seen one sentence in Gujarati on a board. To address this, he suggested displaying more signboards and banners in Gujarati as a means to keep the language alive. He expressed concern that many in the younger generation are unable to speak Gujarati, whereas children from Hindu and Parsi families are often fluent. He urged the Jamaat to focus on this issue and initiate a movement to preserve the language, offering to collaborate on this effort.

Mr. Safeer Hussain raised concerns about the recent increase in school fees, specifically a 200% charge for stationery and worksheets that was imposed without prior notice. He stressed that such fees should be communicated to parents at the beginning of the academic session to help them plan financially. Additionally, he mentioned annual charges that were not applied this year, which further added to the financial burden on families with multiple children. He suggested that advance notification would help families better prepare for these costs, especially when facing financial constraints.

Mr. Ali Raza Rajani brought up the issue of children with special needs, referencing an initiative proposed during the AGM two years ago. Although a foundation stone was laid for the Ata-e-Fatimah forum, no progress had been made. He suggested that, like the full waiver of fees for senior citizens at the sports complex, fees for children with special needs should also be fully waived. Furthermore, he recommended that Mr. Yawar Kumaili hold evening sessions at the Jamaat office to address community issues, as many working parents are unable to attend meetings during regular office hours. Mr. Shahid Saleem expressed his appreciation for the Jamaat's activities, particularly commending Mr. Virani's contributions to the sports complex. He emphasized the importance of reforming the Jamaat's Constitution and noted that a draft has been shared with key members for review. He stressed that discussions from the AGM should result in tangible actions and that an action plan should be developed to address the issues raised, ensuring progress by the next meeting. He insisted that a proposed constitution be available for voting at the meeting, and expressed his frustration at having to remind members about unresolved issues from last year. He highlighted the need for the AGM discussions to lead to practical implementations, not just remain on paper.

Additionally, Mr. Saleem raised a concern about membership criteria, specifically in cases where a Khoja woman, who married outside the community but is now separated from her husband, wishes to join the Jamaat. He argued that such a woman should be granted membership, as she is still a Khoja. While he acknowledged that her non-community husband could not be granted membership, he woman's emphasized that denying the membership could harm the community's future. He called for greater flexibility in the membership criteria, while still maintaining the integrity of the community.

Mr. Muhammad Ali Khandwala raised a concern regarding the Rs. 200 fee for senior citizens' membership cards. While the community includes both affluent and economically disadvantaged members, he emphasized the need to consider those who cannot afford this fee.

Mr. Muhammad Basheer Bhojani raised several issues, including questions left unresolved from 2021 and 2022. He inquired whether, similar to nikah cases where a rubber stamp for 5 tolas of gold is used as mahr, a similar stamp could be applied in divorce cases. This would clarify the obligations of the male partner, especially for women who have the right to initiate divorce. Additionally, he sought clarification on page #68 of the report regarding FMS, which mentions 410 students. He asked how many of these students were Khoja versus non-Khoja.

In response, Mr. Yawar Abbas Kumaili addressed Mr. Sarwar's concerns, particularly regarding the availability of medications in the pharmacy department. He explained that the hospital is actively working on these issues, with Mr. Mehdi Nayani leading the team. Over 90 consultants work across 27 specialized fields, and they strive to provide the best possible service. Pharmacists regularly update doctors on unavailable medications and maintain a register to track them, adhering to corporate standards rather than functioning like a retail shop. Additionally, they have implemented a comment board for weekly feedback from doctors on medication formularies, ensuring ongoing improvements.

Mr. Kumaili also highlighted the efforts to ensure that widows from HBT (Haidery Benevolent Trust) have access to all required medications at the pharmacy. Panels have been established to address any challenges these widows may face.

Regarding the welfare tokens, Mr. Kumaili mentioned that the welfare desk team, including Mr. Sajjad and Mr. Ali Asghar, has been available on all working days for assistance. A sub-committee has been formed to address issues related to education, hospital services, and the Ansar project. The Jamaat is committed to providing support for a range of matters, including rent, electricity, and assistance for students in other schools or those hospitalized elsewhere.

Mr. Kumaili concluded by emphasizing the Jamaat's commitment to supporting all members of the community. The organization is better equipped to address these issues, with the help of the Khums of Imam A.S. and the dedication of various teams working towards the betterment of the community. Mr. Yawar Abbas Kumaili shared a comprehensive update on the Jamaat's welfare activities. He began by highlighting that Fatimiyah Hospital received welfare support of 56 million rupees, including contributions from Khums, Sadaat, and the World Federation. A portion of this, 13.56 million rupees, was used to assist 2,810 community members, with the hospital offering various discounts on bills, OPD, and emergency services. However, there are 7 million rupees in expenses that are not covered by Khums and are being adjusted from hospital revenue.

Regarding education, Mr. Kumaili mentioned that the Jamaat provided a 57-million-rupee subsidy this year for its education network, which serves 2,966 students. Of these, 1,637 students, including 612 members, face financial difficulties even after discounts. The total subsidy for members amounted to 21 million rupees, which demonstrates the Jamaat's commitment to supporting education within the community.

Mr. Kumaili also provided details on the Ansar Project, which supports white-collar families. From its start in 2018 with 18 families, the program has now expanded to support 227 families. A total of 11 million rupees has been allocated to this project, with funds directly deposited into the families' bank accounts for privacy and dignity, rather than providing cash.

The Jamaat also distributed rations and Eidi to the community, worth a total of 37.6 million rupees. This included 2,558 ration packages and 1,947 Eidi distributions. Additionally, the Jamaat contributed 1.44 million rupees to assist with the marriages of community members' daughters. These efforts, along with the 10% subsidy, contributed to an overall welfare disbursement of 177.5 million rupees.

Under the Sehatmand Jamaat scheme, 2,000 cases were addressed, covering 2.25 million rupees for members unable to pay premiums. This initiative ensures that all members, regardless of financial status, can access healthcare services by filling out the necessary forms. Lastly, Mr. Kumaili shared the student enrollment figures for Jamaat's educational institutions as of June 2023, with a total of 2,966 students enrolled, including 1,111 community members. This reflects the significant presence of community members in the Jamaat's education network.

In response to Mr. Yousuf, Agha Shaheedi responded to concerns regarding senior citizens' seating on buses, acknowledging the seating issues during the trip to Wadi-e-Zainab S.A. He also addressed a suggestion to recognize volunteers in the annual report, explaining that volunteers frequently change, but the matter would be revisited in future meetings.

In response to Mr. Rizwan Merchant's question, Agha Shaheedi responded that the selection of the election chairman involves a thorough process of evaluating not only the candidate's team but also their capabilities. While some candidates may not have a team initially, they are often capable of assembling one. All proposals from candidates are carefully reviewed, and based on their qualifications and the strength of their support teams, a shortlist is created for further consideration.

In response to Mr. Rizwan Merchant's query about the result of YES program, Agha Shaheedi responded that YES program is an awareness series but now we are expanding it into a business incubator to nurture entrepreneurial skills within the community. The initiative is expected to launch by mid-January 2024, and it will be open to both males and females. The Jamaat has advertised for a Project Manager position and received numerous applications, with the hope of selecting a community member for this crucial role.

Additionally, a system is being put in place to support white-collar members, allowing them to avoid the need to visit the Jamaat office. In the past, Ramadan rations were delivered directly to homes; however, this method did not work for all families. For instance, some families living in neighborhoods with only one or two needy households felt uncomfortable receiving aid at their homes. To address this, an online registration system was introduced, which has increased the number of cases from 1,250 to 1,950, making it more convenient for white-collar members to request assistance.

We assess all cases for Ramadan ration assistance. including requests from affluent areas where some members are unemployed. Although there are still areas for improvement, Mr. Irfan Rawjani is actively working on this process, albeit at a slow pace. Many dedicated volunteers, such as Mr. Rizwan Merchant, Mr. Kumail Firdous, and Mr. Zafar Rajani, are providing valuable support. Our team, including Mr. Askar and Mr. Mehdi, is overseeing various aspects of the initiative. Insha we anticipate Allah, greater volunteer engagement in our YES program, incubator, and other future projects. Additionally, we have launched separate appreciation programs for male and female volunteers to recognize their invaluable contributions.

Mr. Mohsin Ali Gheewala announced plans to convert the unused squash area at the FSC into facilities for indoor cricket and futsal. The estimated cost for this project is between 7 to 8 million rupees, a substantial amount. Although this discussion was postponed six months ago due to other priorities, it is now timely to revisit the project, especially since the squash court has low utilization rates.

He also noted that special children and their attendants have been given free access to these facilities for the past year and a half. Mr. Gheewala emphasized that the Jamaat's primary responsibility is to fulfill operational assignments, which we manage throughout the year by providing tangible solutions to the community's needs.

Furthermore, he highlighted the importance of identifying future gaps and potential challenges. To encourage forward thinking, the Jamaat introduced the YES series, designed to expand community perspectives. Although immediate results may not always be visible, the initiative

focuses on developing collective community thinking and exploring potential solutions. We are fortunate to have various community organizations that offer loans and support for growth and development. One of the main objectives of the YES series is to connect with the youth and foster critical thinking. By engaging members individually, we aim to create an environment where everyone can share their experiences and contribute to the community's progress.

In response to suggestions from Mr. Rashid Abdullah and Mr. Yasin Merchant, the Honorable Secretary expressed regret in Gujarati about his limited fluency in the language, which he views as a personal shortcoming. He acknowledged that neither he nor the newer generations of community members have adopted Gujarati as a spoken language, a matter of concern. Despite efforts to place Gujarati language boards in the community, many members still struggle to read and write the language, creating a significant drawback, especially when preparing official documents like the AGM draft, for which he often seeks confirmation from others for accuracy.

The suggestion to implement a half-hour Gujarati language class in schools was well received. However, despite efforts by Mr. Igbal Noorani and the late Aun Ali Devjani a few years ago, interest gradually waned. The Secretary shared that he had participated in these classes, but attendance declined sharply from 16 to just two students, including Mr. Ashraf. The lack of interest remains a barrier, and both the Secretary and the President, who also struggle with the language, have not enforced attendance. Moving forward, they will encourage children to attend these classes in an attempt to spark greater interest. Additionally, participation in the annual Gujarati Mushaira has also decreased, dropping from 200 participants to around 100. As a result, the annual report cannot be printed in Gujarati since very few members can read it. Despite its cultural importance, it has limited practical use.

Regarding the welfare of senior citizens, the Secretary noted that health facilities available to them are the same as those for other members. However, they have started placing a "Senior Citizen" logo on membership cards to facilitate access to government benefits, particularly through Nadra, and to ensure they receive discounts at our hospital, FSC, and FMS.

Regarding ration distribution, it was clarified that this process is managed by Mr. Raza Noorani and not directly by the Jamaat. If the Jamaat were to handle the distribution, it would ensure that the process is inclusive, providing rations to all members with prior notice and proper marketing. The Jamaat aims to provide support to all members with prior notice. The team is currently working to improve the ration supply process following complaints from Mr. Raza. Requests for assistance from specific individuals will be reviewed. Given the increased challenges faced by community members in recent months, the Secretary emphasized that funds are limited, and many donors are also facing financial difficulties. Nonetheless, the Jamaat remains committed to supporting those in need and encourages individuals to reach out if they know of anyone requiring assistance.

Concerning insurance coverage for senior citizens, the Secretary mentioned that they have already been registered under the welfare program. To better facilitate their needs, members are encouraged to submit their cases by filling out the relevant forms. This helps the Jamaat assess their financial situations, whether they are unable to pay at all or can contribute 50%, allowing for appropriate support. Currently, the Jamaat is not working with New Jubilee Insurance Co. Ltd. but is negotiating with various other insurance companies, a process that has proven challenging. In cases where a member's insurance card is not accepted by the hospital, they can pay out of pocket and seek reimbursement either directly or through the Jamaat. Sometimes hospitals may refuse to accept the insurance due to errors or other reasons, complicating the matter. The

Jamaat has negotiated with the insurance company for family coverage limits of around 1 million PKR, though this proposal has yet to be accepted. Members facing issues are encouraged to file complaints, but they are asked not to suggest any wrongdoing on the Jamaat's part, as the organization adheres to strict ethical standards and does not engage in any kickbacks.

Currently, we are insured with Alpha Insurance, which is the wholly owned subsidiary of State Life Insurance Company Limited. We receive more benefits from them relative to the premiums we pay. However, due to high claims, these companies are often reluctant to renew their offers without increasing the premium. We typically register individuals who are more likely to face health issues, leading to higher claims than the premiums paid. As a result, the renewal premium for the next term has increased. To address these challenges, we have introduced a new sum insured limit of 500,000 PKR this year, in addition to the 250,000 PKR limit from the previous year. This adjustment was necessary, especially for patients visiting larger hospitals like Aga Khan, where treatment costs can quickly exceed the available coverage in just a few days.

The incorporation of attendance records for elected members in board meetings is not a legal requirement. This practice, which was previously established as a tradition within the Jamaat, has now been deemed unnecessary by the management. Regarding negotiations with pharmaceutical companies, we are actively working on this matter and will seek their services if needed to achieve better results. We have also noted Mr. Raza Devjani's suggestion about a discounted ration offer scheme for members, especially during Ramadan, although implementing such a scheme year-round presents significant challenges.

Mr. Nisar Hamdani, Chief Advisor of Fatimiyah University, expressed his satisfaction with KPSIAJ as a non-profit organization. He emphasized that while hidden profits can exist in any organization, KPSIAJ operates transparently. This is his second time attending the AGM of KPSIAJ, and he acknowledged the philanthropic spirit present within the organization. He pointed out that while many NGOs are founded with enthusiasm, challenges such as team building, accountability, effective fund utilization, governance, and financial management are common. However, he commended KPSIAJ for its well-organized structure and for conducting a productive meeting.

Mr. Hamdani appreciated Mr. Askar's analysis and defense of the financials, noting the effective combination of senior leaders like Abul Hassan Saheb and Agha Shaheedi, which he found remarkable. He remarked that KPSIAJ has seen significant growth over the past three to four years due to the synergy between seasoned leadership and the vitality of youth leaders. He highlighted the university project as the most ambitious initiative currently undertaken by the Jamaat, suggesting that although it may seem small initially, its impact will be felt in just five years as graduates enter the workforce and contribute to the community and the nation.

He mentioned the importance of providing opportunities to all youth, regardless of their eligibility for Khums and Zakat, referencing the teachings of Ayatollah Syed Ali Sistani, who emphasizes inclusivity and support for the youth of the nation. Mr. Hamdani noted that, as a community, we are positioned to support the establishment of the final government of Imam e Zamana AJF and must avoid discrimination based on caste or community.

Having dedicated his time to Jamaat, Mr. Hamdani stressed that the 244 universities currently in Pakistan should not merely be replicated. Fatimiyah University must fulfill a unique role, offering not just degrees but also skills, ethical standards, and professional development. He underscored the necessity of a values-based curriculum that emphasizes integrity and truthfulness.

He expressed gratitude to Mr. Sarwar for his kind words, attributing the university's vision to a

collective effort led by dedicated individuals like Mr. Abul Hassan, Agha Shaheedi, Mr. Baqar Gokal, Mr. Ashraf Haidari, and Mr. Mazher Jumani. He also acknowledged the contributions of young leaders such as Mr. Asker, Mr. Mohsin, Mr. Yawar, Mr. Zahid, and Mr. Mehdi, whose commitment and professionalism will drive the university's success.

Mr. Ali Raza Devji proposed that membership cards be printed in large Gujarati letters, especially for senior citizens. He suggested that there should be two versions of the card: one in Gujarati and another in English and Urdu. This would facilitate identification at the gate, confirming that the person belongs to the Gujarati community.

Mr. Murtaza Ali Sayani informed the members that a family insurance card system, similar to the one used by the Memon community, is being developed. This proposal, previously mentioned by Mr. Merchant, is expected to be available within one to two weeks. Mr. Sayani indicated that he would present this design to the Jamaat and welcomed discussions with him or Chief Operating Officer, who is overseeing the process.

The Honorable Secretary addressed concerns about the availability of OPD tokens at Fatimiyah Hospital, noting that tokens are issued starting at 9 AM, which creates difficulties for non-residents of Soldier Bazar. He reiterated a longstanding suggestion to introduce an online registration system to streamline the process.

Mr. Mohsin Dharsi commented on the 17 crores spent on welfare activities, including hospital support, education, Ansar projects, Eidi, rations, and marriage relief under the Sehatmand Jamaat initiative. While acknowledging the benefits, he questioned the sustainability of such efforts and emphasized empowering the community for self-sufficiency. He proposed using idle school facilities in the afternoons for short courses on entrepreneurship and suggested providing 5 lakh rupees to 400 families to engage in ventures like Bykea, promoting dignity and independence over-reliance on rations. The Secretary referred to a proposal by Mr. Ali Wazir to introduce Gujarati language classes for community children and encouraged collaboration with Mr. Hasnain Poonawala, Deputy Executive Director of the Fatimiyah Education Network, and Mr. Jamil Kazmi, Executive Director. He expressed interest in Mr. Wazir's insights on university initiatives and suggested analyzing the feasibility of addressing Class IX computer education challenges.

Regarding the persistent parking issue at Fatimiyah Hospital, the Secretary explained that efforts to resolve it, including discussions with the Police Department and the Governor, have not succeeded. Proposals to convert the road outside the hospital into a one-way street and to designate a parking area remain unapproved despite ongoing appeals to the government.

Mr. Asker Ali Basrawala informed members that incremental costs at the non-profit Fatimiyah Hospital directly affect its deficit. Bank charges of 1.50% to 1.75% on ATM transactions remain under negotiation for the waiver, and discussions with Bank Al Habib Limited aim to install another ATM on Jamaat premises within 3 to 4 months. Efforts are also being made to transition the financial portfolio to Islamic Banking, with challenges posed by lower profit rates (2% to 3% lower than conventional banking). Fatwas from Marajeens ensures that charitable activities align with Shariah principles, and Mr. Basrawala continues to explore terms to facilitate this transition.

In response to Mr. Safeer Hussain's suggestion, the Secretary acknowledged the importance of defining the fee structure at the start of each session to aid parents in budgeting. Currently, annual and stationery fees are charged later in the year to reduce financial strain. Discount initiatives for Fatimiyah Hospital patients will be gradually expanded, and similar plans are under consideration for education and welfare. Discussions are also underway to use insurance to cover needy hospital cases without requiring patient disclosure. Welfare assistance will be determined based on detailed criteria, including income and family size.

In response to Mr. Ali Raza Rajani regarding the Ata-e-Fatima program for special children, the Secretary highlighted plans to provide daycare, education, and therapy at a ground-floor flat near Khurasan Mosque, operational from January 2024. This facility will enable these children to participate in activities outside their homes, with counseling and guidance sessions available for their parents. Additionally, the media department will inform members about fee waivers at the Sports Centre for senior citizens, special children, and their caregivers.

The Honorable Secretary commended Mr. Shahid Salim for his efforts in drafting and suggesting amendments to the Jamaat Constitution, noting that the document aligns with points discussed in prior Management Committee meetings. This initiative, led by Mr. Hassan Akbar, is well-regarded within the community. However, due to time constraints, the amendments could not be presented at this AGM. The task will be completed before the upcoming elections, either through an extraordinary general meeting or by the newly elected team.

Addressing inquiries about daughters of the community marrying non-Khojas, the Secretary clarified that they remain Jamaat members as long as they retain their Shia faith. Their spouses may become associate members if Shia, but non-Shia spouses are ineligible for membership.

On promoting business engagement over welfare dependency, the Secretary acknowledged efforts by Mr. Mohsin Dharsi, Mr. Ayaz Thaver, and others, while noting limited success so far. The incubator process was introduced to foster entrepreneurial ventures, and while progress is ongoing, awareness among members needs further development.

Mr. Asker Ali Basrawala elaborated on measures implemented over the past three years to address members' needs, categorized as temporary, long-term, and skills development. Short-term solutions include ration distribution, immediate education, and discounted medical support. Various courses have been conducted to align with these goals, demonstrating efforts to build sustainable support systems.

Mr. Asker Ali Basrawala outlined initiatives aimed at addressing the community's long-term educational and skill development needs. These include providing skills training for children through computer development programs, enabling them to pursue freelancing or employment opportunities. A four-month training program, conducted in collaboration with M/s. Consulate is ongoing, with the second batch in progress. Additionally, a data analytics training batch announced three months ago through Karachi AI and Consulnet Corporation is nearing completion. Plans for the establishment of a university and the expansion of Fatimiyah Hospital will further enhance educational and healthcare opportunities. Vocational training and business incubation initiatives have also been introduced to support skill-based development and promote entrepreneurship.

In response to Mr. Mohsin Dharsi's query regarding the increase in the number of beneficiaries from 1,250 to 1,950, the Secretary explained that some employed individuals still require support due to ongoing financial struggles. He further clarified that while concerns about this change were valid, the AGM session was primarily focused on addressing members' questions, limiting the scope for a detailed discussion on the matter.

The Secretary noted that Jamaat would not duplicate the efforts of organizations already supporting small business ventures but would address any identified gaps. While collaboration or joint ventures may be considered, the Jamaat cannot provide financial assistance of 1,000,000 rupees to all 1,950 families, particularly as some may not actively seek business opportunities. Assistance will focus on those lacking financial means to acquire resources like rickshaws or bikes from other sources. Regarding the senior citizen card, it currently includes only a membership tag but allows access to the Fatimiyah Sports Centre and its recreation room. Suggestions to include Gujarati text are under review, with possible health benefits for senior citizens being considered in the future.

In addressing the concern raised by Mr. Bashir regarding the inclusion of a rubber stamp for "right of divorce" or "wikalat" on daughters' nikah namas, the Secretary highlighted ongoing progress in discussions with Ulema, while acknowledging that certain technicalities remain unresolved. He explained that the initiative is moving forward, with provisions requiring proof before a qualified Aalim or Counselor to limit the absolute right of divorce.

In response to Mr. Ali Raza Vazir's concern regarding the delay in circulating AGM draft minutes, the Secretary apologized and acknowledged the longstanding nature of the request. He assured that steps would be taken to address the matter promptly.

In a concern raised by a member, Hon. Secretary clarified that educational donations are not only derived from Sehm-e-Imam A.S but a major portion is from the general donations and emphasized that permission to admit non-Shia and non-Muslim students into Jamaat's institutions had been granted 15–16 years ago by Agha Sharistani.


#### **CLOSURE OF MEETING**

The Honorary Secretary invited the President of KPSIAJ to address the members. The President emphasized the importance of carrying forward the lessons of resilience and stability, inspired by the events of Karbala and the martyrdom of Jenab-e-Syeda S.A. He urged members to remain mindful of global injustices, particularly the ongoing suffering in Palestine, and to continuously pray for the oppressed. The President also stressed the importance of truth-telling while exercising discretion to avoid discord and warned against gossip, which undermines community values. He expressed gratitude for the members' support and maturity during the AGM and highlighted key initiatives, including the expansion of Fatimiyah Hospital, the establishment of Fatimiyah University, and future projects such as business incubators, youth forums, and community housing. He introduced Dr. Hamdani, an esteemed academic, as a valuable resource for the community. A resolution condemning Israel's actions in Gaza was proposed and unanimously passed, and the meeting concluded with a collective recitation of Dua-e-Imam-e-Zamana A.S.



## **REPORT OF THE AUDIT COMMITTEE**

The Audit Committee is pleased to present its report to the Community Members for the year ended June 30, 2024.

#### **Composition of the Audit Committee**

The Audit Committee comprises four members, two of whom are nominated by the President from the Managing Committee and two independent members selected from the broader community. The Chairperson, an independent member, leads the committee.

All members are seasoned finance professionals, each with over 10 years of experience in financial management and governance of large organizations. The Head of the Internal Audit function serves as the Secretary to the Audit Committee.

#### Meetings of the Audit Committee

The Audit Committee, under its terms of reference, is required to meet quarterly. However, during the year, the committee convened 12 times, reflecting its proactive engagement. Key activities included reviewing major audit findings, monitoring remediation actions, and approving the 2024-2027 Audit Plan.

The Secretary circulates meeting minutes to all committee members, and significant matters are reported to the President via Managing Committee representatives.

#### **Risk Management and Internal Controls**

Recognizing the critical role of governance and internal controls, the organization has dedicated Internal established а Audit Department reporting directly to the Audit Committee. Together, they are building a robust internal control framework across all major functions, designed to identify risks and implement timely mitigating strategies.

This initiative reflects the organization's commitment to transforming into a world-class institution that serves the needs of its community effectively.

#### **Internal Audit**

- The Internal Audit Department executed its duties in line with the approved Annual Audit Plans. The Committee reviewed significant findings and ensured appropriate action or management escalation where necessary.
- The Audit Committee has facilitated confidential reporting channels for staff and management to raise concerns about financial or other improprieties. Appropriate remedial measures were applied when required.
- The Head of Internal Audit has unrestricted access to the Chairperson and met with the Committee in the absence of management at the year-end meeting. Management fully supported internal audit activities, providing timely and transparent access to information. All audit recommendations were agreed upon for implementation without conflict.
- The Committee ensured that the Internal Audit function is adequately staffed with skilled personnel and empowered with necessary access to management, information, and resources.

### અલ્લાહ સાથે તાઅલ્લુક (સંબંધ)

આજે દેશમાં કાચદો અને વ્યવસ્થાની પરિસ્થિતિના લીધે મોટાભાગના લોકો ચિંતીત રહે છે. તેઓને હંમેશા પોતાની જાન માલનો ડર લાગેલો રહે છે તેથી અમે જીવન અને સંપત્તિના રક્ષણ માટે વિવિધ રીત–પદ્ધતિનો ઉપયોગ કરીએ છીએ, અંગત અંગરક્ષકો રાખે છે. ઘરો અને ઓફિસો માટે સીકથુરીટી ગાર્ડ રાખીએ છીએ. કિંમતી માલ–મિલ્કતો બેંકોમાં રાખીએ છીએ, વીમો કરાવીએ છીએ અને એવા બીજા કામો પણ કરીએ છીએ. દેખીતી રીતે બધા બોદ્ધિકો આ કરે છે. એ સ્વાભાવિક પણ છે અને આપણે કરવું પણ જોઈએ. દીને ઈસ્લામ દીને ફીતરત છે અને એટલે જ તે આપણને રોકતો પણ નથી. બલ્કે તે આપણને સલામતી અને રક્ષણ માટેનો હુકમ પણ આપે છે. પરંતુ તેની સાથે સાથે દરેક મુસલમાને અલ્લાહની ગેબી મદદ ઉપર પણ ભરોસો કરવો જોઈએ કેમકે અલ્લાહ તઆલા પોતાના બંદા પર ઘણો મહેરબાન છે અને દરેક વસ્તુ કરવા સક્ષમ પણ છે અને તે દુશ્મનોના દિલોમાં પણ રહેમ નાખી શકે છે અને આંખો પર પરદો પણ નાખી શકે છે.

અલ્લાહની ગેબી મદદના હવાલેનો અર્થ એ છે કે નીફાક ફી સબીલીલ્લાહ અલ્લાહની ખાતર ખર્ચ કરો. અલ્લાહની રાહમાં ખર્ચ કરો. ગરીબો અને મોહતાજોની મદદ અને જરૂરતમંદોની જરૂરત પૂરી કરવી અને જ્યાં જરૂરત હોચ ત્યાં સામુહિક રીતે ખર્ચ કરવો એક બહેતરીન સદકો છે. આ હવાલે છઠા ઈમામ હઝરત ઈમામ જાફરે સાદીક (અ.સ.)નો એક કિસ્સો જે બેહારૂલ અનવારમાં છે તેનો ઉલ્લેખ કરી રહ્યા છીએ.

હઝરત ઈમામ મુસા કાઝીમ (અ.સ.) કહે છે કે એક વખત મારા વાલિદ ઈમામ જાફર સાદીક (અ.સ.) એક કાફલા સાથે કચાંક જઈ રહ્યા હતા આ કાફલામાં ઘણા શ્રીમંત લોકો પણ હતા જેમની પાસે ઘણી માલ–મિલ્કત હતી. રસ્તામાં કોઈએ કાફલાવાળાને કહ્યું કે આગળ અમુક ચોર બેઠા છે અને લોકોની સંપત્તિ લૂંટી રહ્યા છે. આ સાંભળીને કાફલાવાળાઓનું શરીર ધ્રુજી ઊઠયું કંપારી છૂટી આવી અને તેઓ ડરથી કાંપવા લાગ્યા. ઈમામ સાદીકે પૂછયું :

'શું થયું ?'

તેઓએ કહ્યું કે અમારી પાસે ઘણો ખઝાનો છે અને અમોને ડર છે કે ચોર–ડાકુ અમારી સંપત્તિ લૂંટી લેશે. તેઓ ઈમામને પૂછવા લાગ્યા કે શું એવું બની શકે છે કે આપ અમારી સંપત્તિ તમારી પાસે રાખી લો. કદાચ તેઓ તમારી પાસેથી ન લૂંટે.

ઈમામે ફરમાવ્યુંઃ તમોને શું ખબર ? થઈ શકે છે કે ચોર મને જ લૂંટવા માંગતા હોય ? અને મારી પાસે રાખવાના લીધે જ તમારી સંપત્તિ નષ્ટ થઈ જાય ?

કહેવા લાગ્યા કે પછી અમે શું કરીએ ? શું અમે જમીનમાં દાટી દઈએ?

ઈમામે ફરમાવ્યું: નહીં કેમકે તેનાથી તમારો માલ વેડફાઈ જશે. કોઈ ત્યાંથી નીકાળી પણ

શકે છે. અને થઈ શકે છે કે તમે માલ–મિલ્કત જ્યાં દાટેલી હોચ તે જગ્યા ભૂલી જાવ અને પછી કચારેચ તમોને તમારો માલ ન મળે.

તેઓ કહેવા લાગ્યાઃ પછી અમે શું કરીએ?

ઈમામે કહ્યું : કોઈ એવી વ્યક્તિ પાસે રખાવો જે તેની હિફાઝત કરે, તેની હિમાયત કરે અને તેમાં વધારો પણ થતો રહે. અને જેટલી તમારી જરૂરત છે તેનાથી પણ વધારે તે સંપૂર્ણ કરી દે અને પાછો પણ આપે.

આ સાંભળી કાફલાવાળા કહેવા લાગ્યાઃ એવું અમાનતદાર વળી કોણ છે ? આપે ફરમાવ્યુંઃ રબ્બલ આલમીન. (અલ્લાહ તઆલા)

તેમણે કહ્યું: અમે તેમની પાસે અમારી અમાનત કેમ રખાવીએ?

ફરમાવ્યું: ગરીબ મુસલમાનને સદકો આપીને.

કહેવા લાગ્યાઃ આ વેરાન જંગલમાં એવું કોઈ નથી જેને અમે સદકો કરીએ.

આપે ફરમાવ્યુંઃ તમે નિચ્યત કરો કે તમારી સંપત્તિનો એક તૃતિચાંશ ભાગ અલ્લાહની રાહમાં ખર્ચ કરો એ તમારા તમામ માલને સુરક્ષીત રાખશે જેનો તમને દરેક તરફથી ડર–ભચ છે. કહેવા લાગ્યાઃ ઠીક છે અમોએ નિચ્યત કરી લીધી.

ફરમાવ્યું: હવે તમે અલ્લાહની સલામતીમાં છો, ચાલવાનું શરૂ કરો.

પછી કાફલો રવાના થયો અને સફર દરમ્યાન ચોર–ડાકુનો સામનો કરવો પડયો. ઈમામે ફરમાવ્યું: ડરો છો શા માટે ? તમે અલ્લાહની અમાનમાં છો.

થોડીક વાર પછી ચોર–ડાકુ નજીક આવ્યા અને ઘોડા ઉપરથી ઉતરી ઈમામે સાદીક (અ.સ.) પાસે આવ્યા અને તેમના હાથ પર બોસો લીધો અને કહેવા લાગ્યાઃ કાલે રાત્રે અમારા સ્વપ્નમાં અલ્લાહના રસૂલ (સ.અ.વ.) આવ્યા હતા તેમણે હુકમ આપ્યો કે આપની ખિદમતમાં પેશ થઈ જાઉં. તો અમે આપની અને કાફલાની સાથે છીએ રસ્તામાં કોઈ પણ ડાકુ કે કોઈ હુમલો કરે તો અમે આપનું રક્ષણ કરીશું.

ઈમામે ફરમાવ્યુંઃ અમોને તમારી જરૂરત નથી જેણે તમારાથી અમારૂં રક્ષણ કર્યું તે રસ્તાના દુશ્મનો અને બીજા ચોર–ડાકુઓથી પણ અમારૂં રક્ષણ કરશે.

## **INFRASTRUCTURE AND EXPANSION**

KPSIAJ is making significant advancements in its commitment to improving healthcare and education. With several critical construction projects underway, these efforts reflect the organization's dedication to addressing key challenges and driving sustainable growth.

### Construction of the 1000-Square Yards Plot (Plot No. 272/4)

Construction has commenced on the 1000-square yards plot located to the right of Fatimiyah Hospital. The structure includes two basement levels designated for parking, solving the ongoing parking issues faced by hospital staff and patients.

Above the basements, the building will feature a ground floor, a mezzanine floor, and three additional floors. This expansion will greatly increase the hospital's capacity, addressing the shortage of beds and space. It will also allow the addition of new departments, enabling the hospital to meet the growing healthcare needs of the community.

#### New Apartment Acquisition for Enhanced Operations

To support operations for the new 1000-square yards plot, KPSIAJ has purchased an adjacent 800-square feet apartment. This space will be utilized for storage and other operational purposes, ensuring efficient management of hospital resources and enhancing overall functionality.

#### Acquisition of the 1425-Square Yards Bungalow (Plot No. 272/1)

A 1425-square yards bungalow has been acquired on the other side of Fatimiyah Hospital. Once fully constructed, this development has the potential to provide approximately 70,000 square feet of space. This future expansion will



support the creation of new medical departments, broadening the range of medical services available and ensuring the hospital can continue to deliver high-quality care to the community.

### Plot for Fatimiyah International University (Plot No. 172/1)

KPSIAJ has acquired a 687-square yards plot adjacent to the current Fatimiyah Higher Education System (FHES) building for the future Fatimiyah International University. Once the charter is approved, this institution will mark a historic achievement as the first-ever university under Khoja Jamaat management. Offering world-class academic programs, the university will play a vital role in advancing education and continuing the community's legacy of intellectual growth.

These infrastructure projects reflect KPSIAJ's unwavering commitment to healthcare and education. With the expansion of Fatimiyah Hospital and the establishment of Fatimiyah International University, KPSIAJ is taking transformative steps to meet the evolving needs of the community.

These developments stand as a proud milestone, showcasing a collective vision to provide better healthcare and education for future generations.



# HIRIDJEE EDUCATION LOAN PROGRAM (HELP)

**Overview:** The Hiridjee Education Loan Program (HELP), initiated by the World Federation, provides essential financial support to Khoja students pursuing higher education across various fields. This program assists both male and female students in obtaining undergraduate and graduate degrees, specifically targeting those facing financial constraints.

**Application Process:** Students can apply for the HELP program through the KPSIAJ website by completing an online application form and submitting the required documentation. A dedicated committee assesses applications based on merit, ensuring that support is allocated to those in greatest need.

**Repayment Plan:** Funds borrowed under the HELP program are repaid over a five-year period, beginning after graduation. Repayments are structured in equal installments to alleviate the financial burden on graduates.

**Donor Commitment:** Generous donors have pledged a total of USD 16,000 per year for four years, aiming to benefit up to 20 qualifying students annually.

**Resources:** For more information, the official KPSIAJ website (KPSIAJ.org) provides FAQs and access to the application form for the HELP Scheme.

**Progress:** As of today, the HELP Program has received a total of 76 applications. Out of these:

- Total Approved: 59
- Total Rejected: 6
- Total Dropped Out: 11

This initiative has enabled numerous students to pursue higher education abroad, contributing significantly to their personal and professional development.

### ELECTIONS 2024: A HISTORIC MILESTONE FOR DIGITAL VOTING IN KHOJA JAMAAT

Every three years, the election process in the Khoja community brings a renewed sense of engagement, responsibility, and dedication to democratic values. For the 2024-2027 term, members gathered once again to elect the Managing Committee and the Secretary. This year's election, however, was marked by an unprecedented innovation in the community's history — a fully digital voting system. This made it the first Khoja Jamaat worldwide to adopt this digital transformation. With support from the Election Commissioner and organized pre-election preparation, this election stands as a landmark event in the community's journey toward modernization and transparency.

#### A Digital First for Khoja Jamaat

Held on Sunday, May 12, 2024, the election not only retained its traditional significance but also embraced new technology at every stage. From digital voter identification to online ballot casting, each step was executed with the permission and endorsement of the Election Commissioner. For the first time, even nomination forms were accessible online, ensuring greater ease for participants and encouraging a more efficient election process.

During the election week, members were also given opportunities to renew or apply for new membership cards, supporting a streamlined experience for all.

This year's Election Commissioner, Agha Ghulam Raza Roohani, was appointed during the previous Annual General Meeting (AGM) held on December 17, 2023. Succeeding Haider Shareef, Agha Roohani led the election commission with a commitment to transparency and innovation. Haider Shareef's tenure as Election Commissioner was marked by consistency and dedication, having overseen multiple election cycles and maintaining a high standard of integrity and inclusivity. His contributions laid a strong foundation for the transition to a digital system, and his service was recognized as instrumental in ensuring smooth, trusted elections year after year.





#### **Pre-Election Preparation and Training**

The transition to digital voting required extensive groundwork. The Election Commissioner's approved team developed a customized voting software from scratch, completing the project within a month. This voluntary effort showcased the dedication of community members to advancing democratic practices.

In addition, the team arranged essential hardware, including 160 Android tablets (10-inch screens), 180 thermal printers, and 40 laptops—all rented for the event. They also purchased 14 routers and network cables, creating a secure, functional network setup for election day.

To prepare members for the new digital voting process, the Election Commissioner personally created a demonstration video. This instructional video was part of a larger voter education initiative that included voting rehearsals held two days prior at Bhojani Hall, Numaish, and one day at Hussainiyah Iranian Bargah, Kharadar. These efforts ensured that community members felt comfortable and confident with the new system.

Voting centers were established at Wali Asr School in Clifton and Hussainiyah Iranian Bargah, with special provisions for elderly or wheelchair-bound members.

#### The Voting Process: Secure and Transparent

On election day, each step of the voting process was meticulously planned to ensure security and transparency. Upon arrival, members were identified digitally and issued a one-time-use QR code slip. They scanned this QR code with a tablet to access the digital ballot, where they could select their candidates. Before submitting their vote, voters had the option to make any final adjustments, further underscoring the election's commitment to accuracy. After submission, a thermal printer generated a physical ballot paper, which was then dropped into a box as a backup record in case of any software malfunction.

The security of the digital system was prioritized at every stage. The three potential President candidates, along with the Election Commission, entered unique codes to encrypt and later decrypt the software, securing the voting data. After the voting period ended, these codes were entered again, allowing the system to finalize and generate the results.

#### Volunteer Support and Community Involvement

Throughout the day, a network of dedicated volunteers from various organizations supported the Election Commissioner in managing logistics, guiding members, and ensuring the election ran smoothly. Their participation underscored the collaborative spirit of the Khoja community and the shared commitment to a fair and transparent election.

The 2024 Khoja Jamaat election was a powerful testament to the community's dedication to democratic values and its openness to embrace modern solutions. Through the hard work of Agha Ghulam Raza Roohani, the volunteers, and the IT team, the community witnessed a seamless, secure, and digitally empowered election. As the results unfold and the new committee steps in, this event will be remembered as a milestone in the community's democratic journey, inspiring other communities to explore similar advancements in the future.



### SEHATMAND JAMAAT HEALTH INSURANCE PROGRAM


Sehatmand Jamaat is a health insurance plan provided by Alpha Insurance Company Limited (a subsidiary of State Life Insurance Corporation of Pakistan) and facilitated by KPSIAJ for its members and employees. This scheme is also available to community entrepreneurs for their office and factory employees.

It offers various medical facilities in the event of hospital admission, with two plan options:

Premium Plan: A coverage limit of Rs. 500,000 and a per-day room rent limit of Rs. 9,000.

Standard Plan: A coverage limit of Rs. 300,000 and a per-day room rent limit of Rs. 5,000.

The scheme covers pre-existing illnesses and congenital diseases, ensuring comprehensive healthcare support. During 2023-2024, a total of 2,958 individuals have benefited from KPSIAJ's insurance program, with ongoing efforts to enhance the policy's effectiveness and coverage.


All members, both male and female, were encouraged to actively participate and cast their votes at the designated polling stations in Karachi:





This initiative underscores our unwavering commitment to education and skill development in the ever-evolving tech industry. The program is designed to impart crucial web development skills across progressive phases:

- Phase 1: Foundational understanding of HTML, CSS, JavaScript, and jQuery.
- Phase 2: Intermediate to advanced modules covering Flutter, Python, PHP, WordPress, MERN, SQA, and React.JS.
- Phase 3: Comprehensive freelancing strategies to equip students for success in the digital marketplace.

This year, two top-performing students were awarded laptops, a testament to our commitment to recognizing and encouraging academic and professional excellence.

#### **KPSIAJ x Karachi Al**

In collaboration with Karachi AI, KPSIAJ continues to organize an advanced AI training program, providing participants with prestigious certifications. These include:

- Certified Data Visualization Expert: Expertise in creating impactful visual representations to aid data-driven decision-making.
- Certified Data Analyst: Proficiency in analyzing and interpreting data for actionable insights.
- Certified Data Engineer: Competence in designing and managing efficient and secure data systems.

These programs are ongoing, with new batches enrolling for advanced training supported by KPSIAJ. The initiative reflects a strategic focus on empowering youth with industry-relevant Al skills.



### RAMADAN RATION DISTRIBUTION

In March-April 2024, during the holy month of Ramadan, our collaboration with the World Federation continued to provide essential support to those in need. As in the previous year, we distributed 2,044 ration bags, each valued at Rs. 11,600, sufficient to sustain a family of five for the entire month of Ramadan.

Additionally, we extended further assistance by providing two ration bags to approximately fifty families with more than five members. Demonstrating our commitment to inclusivity, we also distributed 2,000 ration bags to non-members, including Sadaat, Non-Sadaat, other Muslim communities, and deserving non-Muslim families.



### **CASH ASSISTANCE FOR EID-UL-FITR**



On the occasion of Eid-ul-Fitr, we continued to support deserving families by providing cash assistance (Eidi). A total of 1,985 deserving families received Rs. 6,500 each, and this financial aid was delivered directly to their CNICs through Easy paisa. For 483 beneficiaries over the age of 60, we ensured that the cash assistance was personally delivered to their doorsteps, making the celebrations more accessible for these individuals. This support underscored our commitment to making a meaningful difference in our community's lives.


# KPSIAJ & THE WORLD FEDERATION WINTER PROGRAM 2023




#### Muqabala-e-Husn-e-Azaan



### HUMAN RESOURCE DEPARTMENT

The provided data outlines the recruitment status for local and international positions, categorized by status and job titles. Of the 109 total roles, 95 are local, and 14 are international. Most local positions (88.4%) are filled, with 8.4% in progress and 3.2% canceled. International roles show a 50% fill rate, with the remaining 50% in progress. Key positions filled locally include Accounts Officer, Salesman and Driver, while internationally, Accounts Officer roles are predominant. This data reflects a strong emphasis on local recruitment, particularly in administrative and operational roles.



### **MANAGEMENT INFORMATION SYSTEM** & INFORMATION TECHNOLOGY

Information and Communication Technology (ICT) indispensable for is non-profit organizations. lt streamlines operations, improves communication, and enhances data management. ICT boosts outreach and fundraising efforts, enabling non-profits to extend their impact and garner support efficiently, making it a vital tool for achieving our mission. A detailed report for this year for their remarkable achievements is mentioned below.

#### In-house Software Development

Our dedicated in-house software development team remained busy in continuous coordination with all departments/units for the maintenance of their software. All following software went through different change requests including enhancements in existing software, new feature requests, bug fixes etc.

- Fatimiyah Hospital Information System (FHIMS)
- Attendance / Leave Management and Payroll (TRAC)
- FEN Student Information System (FENSIS)
- KPSIAJ Front Desk Management System

The IT team has also been facilitating the media team with technical assistance where required.

We are looking into increasing the software development team size to take on more tasks at a better pace.

#### Appointment-based consultation at Fatimiyah Hospital

For the convenience of patients/attendants and to increase the overall efficiency of the OPD

department, Fatimiyah Hospital management raised the requirement for a hybrid mechanism for OPD consultations whereby walk-in patients are served as well while prioritizing those who prior appointments. This have booked mechanism was built and is Alhamdolillah operational very smoothly. Currently, appointments can be booked via a desk available at Fatimiyah Hospital or call 021-32226331 or 021-32226652 from Monday to Saturday 10 AM to 6 PM. Our team is working make appointment booking more to convenient via the Fatimiyah Hospital website and WhatsApp virtual assistant.

#### Meal Services

To enhance patient care and improve the overall hospital experience, a well-functioning meal services department is crucial. In response to requests for new meal services features, the development team software not only implemented these but also redesigned the meal services entry screens for optimal touch-based usage on smartphones and tablets. This update, now live, aims to streamline bedside entries, saving time and increasing efficiency. While hardware-related changes are still being addressed to fully enable bedside entries, the software component is already in place.

#### **Android App Updates**

Our Android app received some major functional updates during the year and many more are in the pipeline. Very soon the app will receive more updates to make it more productive and an everyday companion for members. Stay tuned not only for these updates along with the iOS version of the app too.

#### Online Forms

KPSIAJ is committed to providing convenience and ease for its members. To leverage technology, we launched an online membership renewal/duplicate card application form in February 2024. By June, we had received over 1,500 online requests. In March, we introduced an online Form A (for male members aged 18 and above). Within three months, we received approximately 80 completed forms. Our team is diligently working to further simplify this process, making it easier for members to both fill out forms and pay service fees online. We aim to have all Jamaat-related forms available online in the near future.

#### WF Elections 2024

Triennial elections were held across the globe to elect the president of The World Federation of KSIMC for the term 2024-27. This time around, voter verification was done across three polling stations using in-house created software which was operated by KPSIAJ and FEN staff under the supervision of the election commission.

Since 1996, the Fatimiyah Community Center has been offering Ghusal and Kafan services to both its members and the wider public. The Ghusal Khana strives to provide the highest quality in these essential services. Additionally, the center is frequently utilized by members for various programs and majalis.

The selfless and altruistic contributions of male and female volunteers for Ghusal and Kafan rituals are deeply appreciated by the KPSIAJ Management. Over the past year, 335 bodies of both members and non-members were brought to the Fatimiyah Community Center (Ghusal Khana) for Ghusal and Kafan rituals.

#### Sessions on Kafan Cutting & Ghusl Masail

KPSIAJ organized informative sessions on Kafan cutting and Ghusl Masail for women, conducted by the dedicated Ghusl Khana female volunteers. These sessions aimed to educate participants on essential funeral practices, ensuring proper knowledge and preparation.

### GRAVEYARDS

The Alam Kushai program took place on July 15, 2023, at the Wadi-e-Zainab (s a) Graveyard and on July 16, 2023, at Hussain Bagh 1. Members from various locations were provided with free bus services for their convenience. The Alam Kushai Program at Hussaini Bagh 2 is held bi-annually by the Alam Committee, and to facilitate members, free bus service is provided every alternate Sunday for visits to all the aforementioned graveyards. During Eid-ul-Fitr and Eid-ul-Zuha, complimentary transportation services were organized for members to visit Hussaini Bagh 2 and Wadi-e-Zainab (s a) Graveyards from locations including Soldier Bazar, Kharadar, Korangi, and Mehfil-e-Zainab (s a), Nazimabad. ### **MEMBERSHIP**

The total population is 29,857, with a slight male majority of 15,794 (53%) compared to 14,063 females (47%). The community consists of 5,384 minors (under 18) and 24,473 adults (18 and older). Geographically, the majority reside in Soldier Bazar (60%), followed by P.E.C.H.S. (11%) and other areas. The age distribution shows the highest concentration in the 31-35 age group (2,645 individuals), while the aging population (above 80 years) comprises 933 individuals. This demographic overview reflects a balanced community with diverse needs across various ages. groups.

#### **Centralized Security Operations**

To improve the efficiency and reliability of our security systems, we transitioned to a centralized management model. A team of approximately 68 skilled professionals diligently supervises every aspect of security operation, ensuring seamless oversight.

#### Rigorous Personnel Standards

Our security personnel are selected through a stringent evaluation process, focusing on qualities such as vigilance, commitment, and physical fitness. Regular performance and health assessments ensure they are well-equipped to handle any challenges.

#### Streamlined Communication Framework

An integrated network of intercom systems and wireless radios, managed by the Central CCTV Department, connects all operational sites. This streamlined communication infrastructure enables swift decision-making and cohesive security coordination.

#### Advanced Command and Monitoring

Our centralized Command and Control system provides 24/7 monitoring to detect and address potential risks proactively. This setup allows for immediate responses to emergencies, reinforcing our commitment to continuous vigilance.

#### Enhanced Surveillance Network

With over 185 strategically positioned CCTV cameras, our facilities benefit from extensive surveillance coverage. As part of our ongoing commitment to security, we evaluate and expand camera placements to address evolving needs. This includes comprehensive coverage of the Garden plot, ensuring enhanced safety measures.

### TRANSPORT

Our transport department provides services to community members throughout the year. Buses are arranged for members' leisurely tours. On a weekly basis, particularly Sundays, as well as during festivals and special occasions, Jamaat arranges buses for visits to the three graveyards. Students and teachers of our schools and colleges pick-and-drop benefit from services on designated routes. Transport facilities are also provided to students during exams held at various centers across the city. Additionally, every Friday, a bus operates between Jamaat and Shah-e-Najaf Imambargah for Jumma prayers.

Professional coaches and trainers are available to guide young athletes, many of whom have gone on to win titles at provincial and national levels. Regular fitness classes, including aerobics, are held separately for male and female members.

Adjacent to the Fatimiyah Sports Complex, KPSIAJ is fortunate to have the Fatimiyah Family Park. The park includes a jogging track and a variety of rides for children, offering a welcoming space where families, especially women, can enjoy leisure time. ### FATIMIYAH MONTESSORI SYSTEM

#### **Academic Progress and Development**

The progress for includes significant advancements in the College Staff Development and Growth Plan, reflecting ongoing process development efforts. A detailed staff development plan has been formulated with job descriptions and key performance indicators for each grade level was developed.

This program is offered only at Fatimiyah College in the entire city. It is an integral part of the student curriculum, with weekly classes conducted by college counselors.

- a) The revised curriculum aligns with contemporary values and addresses the evolving needs of our students. It integrates value education deeply, ensuring that our students are not only academically proficient but also well-rounded individuals prepared for the complexities of modern society.
- b) The vision of the revised SPEAC Curriculum is grounded in five core domains of education:
  - **Belief:** Cultivating a strong sense of personal, communal, and moral values.
  - **Civics:** Instilling a sense of responsibility and citizenship.
  - **Performance:** Enhancing academic and extracurricular achievements.
  - Intellectual: Fostering critical thinking and intellectual growth.
  - **Emotional:** Supporting emotional well-being and resilience.

Our goal is to nurture students who are not only academically adept but also emotionally intelligent, civically responsible, and confident in their beliefs and performance.

#### Financial Performance

#### a. Admissions

The college has managed to secure more than 300 admissions this year and approximately 85% of available seats in XI have been allocated. The table illustrates XI and XII enrolment status:

• For the first time, a 100% admission fee waiver was provided to KPSIAJ students to increase community inclusion in the college.

 Direct transfers were facilitated for students from Fatimiyah schools. This year, 59 students from Fatimiyah Girls' School (FGS) and 26 students from Fatimiyah Boys' School (FBS) have been enrolled under this scheme,

#### b. Digital Admission Test System at Fatimiyah College

Fatimiyah College's paperless admission system reduces costs by eliminating expenses for paper, printing, and manual processing, offering an eco-friendly and economical solution.

## **QURAN DEPARTMENT**

#### Academics

#### a) Enhanced Character Education

This year, several teachers from Quran department collaborated with the Value Department on character education. They got engaged in research work, lesson planning, microteaching, and translation tasks, in addition to their regular responsibilities.

#### b) Benchmark & SOS Development

A benchmark and Scheme of Study (SOS) were developed for FMS I through Class II to facilitate the acquisition of Quranic teachings. This framework is set to serve as a valuable resource for teacher training in other community schools, supporting the achievement of educational objectives more effectively.

#### c) Islamiat Plans & Proposals

A comprehensive plan and proposal for integrating Quranic studies and Islamic education were developed in class III and IV as a pilot project. This initiative has laid a solid foundation for the effective implementation of the idea that Quran is the source of Islamiat and that Quran must be the book of guidance and not just a book of reward (sawab).

#### Co-curricular

#### a) Ayaat Competition

A competition of memorized thematic verses by Quran Department was conducted for students from FMS I to Class II. The high level of enthusiasm demonstrated by the participants



suggested that the thematic verses will leave a lasting impact.

#### b) Palestine Program

On November 12, 2023, students from the Fatimiyah Montessori System organized a program in solidarity with Palestinian children. The event aimed to foster support for the oppressed and opposition to aggressors. On November 19, 2023, the Fatimiyah Education Network set up a camp at Nishtar Park to raise awareness about the situation in Palestine. At this camp, children engaged in various activities and reaffirmed their commitment to standing against oppression.

#### c) Theme "Imam e Zamana a.j.t.f." in FGS & FBS

During the month of Sha'ban, Quran Department launched a campaign in the FGS and FBS units centered around Imam al-Mahdi (AS). The campaign was designed to introduce the Imam and generate enthusiasm for related activities. A chart outlining specific acts to be performed over several days was provided to enhance the Imam's pleasure and strengthen students' connection with him.

#### d) Exhibition of Quranic Sciences in FGS

Students from Class VI to VIII in FGS organized an engaging exhibition on Quranic themes. The display included models, games, and charts to present topics related to Mafahim-ul-Quran and Hifz-e-Mozui. This exhibition successfully fostered a deeper connection with Quranic themes.

#### Academic Year 2023-24

#### a) Curricula and Progression

- Reviewed the current Grade II and Grade III curricula to identify any gaps or overlaps with the national standards and lower primary curricula.
- Selected the most suitable strategy out of the three available curricula that aligns with the school vision.
- Created a detailed plan for implementing the chosen curriculum.

#### b) Lesson Planning and Development

A simplified IVC (as an alternate to VA) lesson plan was designed for Grades I and II and implemented with 12 teachers. The training program included demonstrations, feedback, and revisions to ensure a clear understanding and effective application of the 4C methodology. The objective was to provide teachers with a standardized and structured approach to lesson planning, aimed at improving the quality of education for students. Trained educators specializing in subjects aligned with the 4C framework, encompassing the Quran and languages (English, Urdu), to facilitate a clear and profound understanding of the subject teaching.

#### c) Assessment and Evaluation

 After carefully reviewing over 100 examination papers as sample with answer scripts from Test 1 and the Midterm, identified some areas of weakness with respect to connectivity with the SLO, s. These weaknesses were analyzed and a comprehensive training program was developed to address them. This program has been meticulously planned to help teachers overcome the identified shortcomings.

 Concept of developing "Question banks" was introduced as it aids in creating exam papers aligned with specific objectives, ensuring standardized and consistent assessments, and promoting fair and unbiased evaluation of student learning. This approach saves time and effort by leveraging pre-existing repositories of questions, making it a valuable tool in academic and business settings.



#### Learning & Teaching

Conducted a 40-day training for all units on pedagogy, including lesson planning frameworks, social - emotional learning, and effective instruction.

#### a) Introductory AI Training for FEN Faculty

A two-episode introductory training on Artificial Intelligence (AI) was conducted for the faculty members of FEN during the summer vacation. The training aimed to familiarize participants with AI concepts and applications, enhancing their understanding and capacity to integrate AI into their teaching practices.

#### b) Learners in Need

We have designed policies for the areas to ensure quality standards, accountability, and guidance.

#### Administrative

PDT plays a crucial role in the recruitment process, involving the assessment of candidates' lesson designs, skills, and content knowledge. The department also administers orientation sessions for new hires, providing tailored training based on unit requests and individual needs.

#### a) Teachers Appointment & Training

We have designed policies for the areas to ensure quality standards, accountability, and guidance.

#### b) Admission Process

Policy developed outlining all steps and their requirements.

Syllabus and admission test papers revised to align with curriculum standards and promote transparency.

#### **Quality Assurance Initiatives**

#### a) Educator Evaluations through Needs Assessment Tests

- Conducted assessments for 70 FGS & FBS teachers and 50 FMS teachers, identifying high proficiency in lesson planning, noting areas needing improvement in soft skills, pedagogy, and content knowledge.
- Pedagogy training was designed and delivered by the PDT team.

#### b) Micro Teaching Sessions (MTS)

 Evaluated over 80 MTS sessions, noting strengths in organization and communication skills among teachers. Training in lesson design and execution was conducted in May 2024.

#### c) Classroom Observations

 Conducted over 30 classroom observations, identifying areas for improvement in lesson plan model comprehension. Further training in lesson design and execution took place in May 2024. A policy on teacher development for classroom observations was designed, shared, and implemented.



#### d) Parent-Teacher Meeting (PTM) Surveys

 Gathered feedback from over 100 parents who, despite limited knowledge of school processes, showed strong trust in the organization.

#### e) Midterm Examination Review

 Analyzed more than 100 examination papers and answer scripts, noting a need for standardized marking schemes. Training for lesson design was conducted in May 2024 to address identified gaps in students' independent problem-solving skills.



#### f) Student Satisfaction Survey

 Surveyed approximately 480 students across 16 classrooms, who expressed enthusiasm for learning and requested improved grading and increased classroom activities.

#### g) Teacher Feedback

 Collected teacher feedback, identifying desires for transparent policies, improved infrastructure, revised lesson plans, and greater parental involvement.

#### Value Departments' initiative for Enhancing Quality

Efforts made by the Value Department to improve value integration in the B.Ed/ADE programs:

#### a) Review and Planning

- Reviewed previous integration work to identify areas for improvement
- Identified key objectives for each specific chapter to enhance integration

#### b) Talent Acquisition and Development

- Conducted interviews for new hirings at FEN to ensure that the resources hired are culturally aligned with the values of FEN.
- Participated in a five-day applied course for translators in Islamabad to enhance professional skills
- Represented FEN at an educational leadership summit in Murree to stay updated on best practices

#### c) Educational Resource Development

 Assessed educational materials such as the "Kifayat" and "Dhanak" series to ensure quality and relevance

### Overall Initiatives by Value Department across FEN and FHES

#### a) Storytelling Initiative at FMS

The Value Department integrated storytelling into the curriculum for Classes I and II, fostering value-based learning. Collaborative meetings with the principal ensured consistent value integration across Classes I-III, supported by teacher training sessions on storytelling as a teaching tool.

b) Character Education Program at FBS and FGS

Through data analysis and teacher interviews, the Value Department addressed behavior management and personality development. Regular Wednesday assemblies emphasized character education themes, reinforcing positive values among FBS and FGS students. Art and library periods were effectively utilized to ensure personality and behaviour development and improvisation into various learning activities.







#### c) Personality Development Initiative Fatimiyah College

Personality development sessions and training programs supported student growth at Fatimiyah College. Efforts included reorganizing the SPEAC (Student Personality Enhancement through Augmented Curriculum) program, designing a new curriculum, and conducting teacher orientation workshops to embed values into the curriculum.

#### d) Value Orientation Program at FHES

The FHES Value Department conducted monthly value orientation sessions for ADC and nursing students while offering personalized guidance to B.Ed. (Hons.) students in philosophy, critical thinking, and psychology courses. Collaborations with faculty contributed to a robust value-based education framework.

#### 3. Value Department's Capacity Building and Collaboration

The Value Department developed a comprehensive syllabus and lesson plans for character education, collaborated with the PDT team for the GUIDE initiative, and organized workshops to enhance teaching strategies and staff collaboration.











### **HEALTH DEPARTMENT - FEN**

This year marked significant progress for the department, with notable achievements and challenges addressed effectively. Patient volume increased, including both first-time and returning patients. Financial discipline was maintained through strategic cost management, such as bulk purchasing of long-lasting medications, optimizing prescriptions, and improving inventory practices.

Patient outcomes improved significantly, with higher satisfaction rates and enhanced treatment success. Safety protocols were strengthened to ensure better care delivery. The department also introduced innovative programs, including medications for childhood diabetes, and integrated advanced technologies like AI and digital tools for efficient data management.

Despite hurdles such as limited working days, staff shortages, and adaptation to the work environment, these challenges were managed through extended hours, task delegation, and support from senior team members. Looking ahead, a structured plan for daily operations aims to drive growth and efficiency across all units.

In January 2024, the department was honored for its contribution to a college symposium, and public health initiatives included polio campaigns, deworming efforts, and vitamin A supplementation programs. These efforts reflect a commitment to excellence and community impact.

#### Key Health Initiatives by the Medical Department

#### a) Successful Polio Campaign at F.M.S and Day Care

А polio campaign was successfully conducted at FMS and Day Care in collaboration with the Citv District Government. Under the supervision of the School Medical Officer and paramedic staff, 223 students under five years were vaccinated. The campaign was led by Lady Health Worker Ms. Saeeda, appointed by the Deputy Commissioner Karachi East.

b) Oral Health Awareness Sessions at FEN Schools

Oral health awareness sessions were held across FBS, FGS, and FMS to educate students and faculty on the importance of dental hygiene. The sessions, led by school organizers and the doctor, emphasized healthy habits, linked oral care to Islamic teachings, and encouraged a lifelong commitment to dental health and overall well-being.

c) Health and Nutrition Awareness Sessions at FEN Schools

Health and nutrition sessions were conducted across FBS, FGS, and FMS, focusing on balanced diets, healthy habits, and well-being in light of Quranic teachings. These interactive sessions equipped students with practical skills to adopt clean eating and foster lifelong healthy habits.

### FATIMIYAH HIGHER EDUCATION SYSTEM (FHES)

#### Introduction

The year 2023-24 has been a remarkable year of growth, achievements, and strategic advancements for Fatimiyah Higher Education System (FHES). Our institution has accomplished multiple significant milestones, including academic expansions, mandatory inspections, human resource and infrastructure development, all aimed at enhancing the quality of education and institutional reputation.

#### 1. Launch of the Associate Degree in Commerce

One of FHES's most significant achievements during the year was the successful commencement of the Associate Degree in Commerce (ADC). The program offers a balanced curriculum that prepares graduates for both immediate employment and further studies, resulting in strengthening our academic portfolio.

#### 2. Regulatory Visits for Nursing Department Affiliations

**Pakistan Nursing Midwifery Council (PNMC):** The PNMC conducted a comprehensive inspection of our nursing facilities, curriculum, and faculty qualifications on 29th December, 2023. Their visit was crucial in evaluating our adherence to the national standards of nursing education. By the Grace of Allah (SWT) we have received the accreditation certificate of PNMC on 26th January 2024.

Sindh Health Department: The Health Department conducted an evaluation visit on 24th January 2024 to assess the quality of healthcare education we are providing in the field of Nursing. Their focus was on aligning our training and educational infrastructure with provincial guidelines, ensuring our students receive education that meets provincial healthcare needs. After the successful visit of the Health Department and follow-up meetings we have received a No Objection Certificate (NOC) from the Health Department on 19th March 2024.

**Dow University of Health Sciences (DUHS):** A major milestone was the successful inspection by DUHS with regards to affiliation on March 6, 2024 and the follow-up visits. Their team assessed our facilities, resources, and academic framework, which brought us one step closer to solidifying our nursing degree affiliations with a prestigious health sciences institution. This visit was highly crucial for acquiring affiliation with the leading Medical University of Pakistan. As a result of the efforts of FSON Head we have been able to acquire the "Affiliation Letter" on 11th September 2024.

These visits are instrumental in ensuring the quality and credibility of our nursing programs and reflect FHES's commitment to fostering a strong and compliant healthcare education system.



#### **3. Intellectual Sessions and Seminars**

Throughout the year, FHES organized multiple intellectual sessions and seminars/workshops to foster an environment of knowledge-sharing and critical thinking. These events were designed to enlighten students and Faculty Members, broaden their intellectual horizons, and equip them with insights from industry professionals and academics. Topics covered in these sessions ranged from contemporary global issues, technological advancements, healthcare innovations, and leadership skills to emerging trends in commerce and economics.

The seminars were well-received by students, community members and faculty alike, with many notable experts contributing to the discussions. These activities have not only enhanced student engagement but also strengthened the academic core of FHES, making it a vibrant learning environment.

#### 4. Progress Toward Establishing Fatimiyah International University (FiU)

One of the most ambitious projects FHES has undertaken is the establishment of Fatimiyah International University (FIU). The journey to acquiring a charter for FIU has seen significant progress in 2023-24:

**SHEC Visit:** As part of the university establishment process, the Sindh Higher Education Commission (SHEC) conducted a preliminary visit on May 21, 2024 to evaluate our facilities, academic framework, human resource and institutional readiness. Following this, HEC provided their feedback and compliance requirements, which were duly addressed by our team.

**Charter Inspection and Evaluation Committee Visit:** The Charter Inspection and Evaluation Committee (CIEC), comprising five Vice-Chancellors from various universities, besides other officials of HEC including its chairman visited FHES to conduct a thorough inspection of our facilities, governance structures, and academic programs.

**Approval Status:** This is a major step forward in our vision to establish FIU, which will serve as a leading institution for higher learning in Pakistan. The final approval of FiU will be authorized by the SHEC commission to be schedule shortly from where the case will be forwarded to the Law Department of GOS.



#### 5. Future Outlook and Strategic Goals

With the many achievements of 2023-24, FHES is now positioned as a forward-thinking institution dedicated to academic excellence and infrastructural growth. Our goals for the upcoming year include:

**Strengthening Existing Programs:** We will continue to enhance the quality of our existing degree programs, particularly in commerce and nursing, by incorporating the latest industry trends and improving faculty development.

**Expanding Academic Offerings:** With the progress of FIU, we aim to introduce more diverse academic programs, expanding into fields such as Engineering, IT, and Social Sciences. FHES is in the process of developing a Faculty Program on Fatimiyah Center of Artificial Intelligence (AI), which hopefully will be materialized in the year 2025.

These ambitious goals reflect the institute's commitment to expanding its impact and further contributing to the development of the healthcare sector.



The year 2023-2024 was the year of development in the area of patient facilitation and redesigning processes for patient satisfaction and improvement of service deliverance and also the scope of the services.

A patient feedback System was introduced with enhanced options utilizing technological advancement for a better overview of patient's input about services as well as the addition of new services as per patients' needs, and this service usage was made easier for patients by displaying at all prominent places of Hospital and social media.

**Online Appointment System** Considering the high flow of outpatients and the limitation of the seating area for the patients' an online appointment booking system was introduced as a pilot project which is running successfully and now extending timing from 8 hours to 15 hours a day except Sundays.

#### The free home delivery system

Fatimiyah Hospital management has a patient centered approach that always considers the patient's convenience and comfort has started Free Home Delivery medicine at discounted rates in Karachi and enhanced patient comfort and satisfaction as part of our mission to serve humanity with zeal and excellence.

**HOD for critical areas** like ICU/HDU and professor-level HOD for Radiology and Laboratory as these all areas are integral parts of clinical excellence along with the addition of new advanced medical equipment along with senior doctors' induction at registrar level and the start of evening round system for effective control of clinical as well as administrative issues round the clock.

The NICU (noninvasive cardiovascular unit) department was developed for early diagnosis and to prevent patients from unnecessary surgical



**Chest Pain Clinic** Qualified doctors with well-equipped clinics provide services to patients to effectively manage their chest pain issues.

**Free BLS/ACLS for Doctors and Nurses.** Fatimiyah Hospital management believes in continuous education and training of their clinical and non-clinical staff for that we signed an MOU for free certified training and license from AHA (American Heart Association) and every month we are getting 10-15 staff trained and certified.

**Fire Marshal Training** as we all know disaster management training is an integral part of safety and security and among basic firefighting skills, is the most important skill the management signed an MOU with the Civil Defense Authority of Pakistan and arranged fire marshal training and certification and it will be an ongoing process.



**Training and development** The FH team had a strong belief in team building and development and was inducted as a T&DM last year. This year an in-house total of 134 pieces of training were conducted and 1884 staff were trained in different topics both clinical and non-clinical areas.

Addition to the Fleet of Consultants. The FH management team with the help of GBs actively hunted for new consultants to furnish the consultancy Boquete with all colors of flowers to match the need to develop a perfect team and achieve the target of clinical excellence.

**QA/QC Department.** The QA/QC department was planned for a long time and Alhamdulillah this year 2023-2024 separate department was developed along with achieving targets of delivering health care services as per National and international



guidelines and complete departmental organogram and entire SOPs developed.

**Expansion of in-house lab facilities** It has always been a dream of our management to convert Fatimiyah into a place of One Window Operation by providing all facilities with quality and economy under one roof and for that we introduced a new machine that can perform all lab tests in the house along with strengthening team of experts for early and accurate reporting. In the laboratory, we introduced a very senior, energetic, and highly experienced MPhil doctor as HOD and team changes were done to ensure timely and accurate reporting and transform the lab into a more cost-effective one with technical advancement and Alhamdulillah with the efforts of team 100% results are accomplished.
